On 17 February 2022, Oversea-Chinese Banking Corporation Limited made an announcement for and on behalf of the Offeror that, inter alia, as at 5.30 p.m. (Singapore time) on 17 February 2022, the Offeror has received in aggregate valid acceptances of the offer of 1,279,932,420 Shares during the offer period commencing from 20 September 2021 to the closing date of 17 February 2022.
