

## OFFICIAL OPENING OF PANJIN AOXIN Q&M DENTAL HOSPITAL CO., LTD

Unless otherwise defined in this announcement, all capitalised terms used in this announcement shall have the same meanings as set out in the announcement dated 21 August 2017.

**Singapore, 20 May 2018** – Catalist-listed **Aoxin Q&M Dental Group Limited** (the "**Company**") and together with its subsidiaries (the "**Group**"), a leading provider of private dental services, distributor of dental equipment and supplies as well as provider of laboratory services in Liaoning Province, Northern PRC, is pleased to announce the official opening of its dental hospital, Panjin Aoxin Q&M Stomatology Hospital Co., Ltd (the "**Hospital**"). This wholly-owned hospital is the first dental hospital to be set up by the Company since its listing on Catalist in April 2017.

The Hospital is located in the city of Panjin, Xinglongtai District, Xinglongtai Street. While the city has the second highest per capita income in Liaoning, its dental practice market is very fragmented with many small clinics providing limited services. The Group currently has two substantial practices in Panjin with more than ten years of reputation for quality of services, familiarity of local conditions as well as an established customer base. The Hospital occupies a standalone building with floor area of more than 3,000 m<sup>2</sup> and it is the first dental practice of this scale in Panjin which allows the Group to further entrench its presence.

The Hospital uses imported dental equipment including Cone Beam Computed Tomography scanner, CAD/CAM system, Erbium laser and digital panoramic X-ray machine. It will draw on the Group's established systems and ready pool of experienced dental professionals to provide a broad spectrum of dental care and treatment including endodontic, orthodontic, periodontics, paedodontics and dental surgery. It is set up in accordance with internationally recognised standards with particular emphasis on hygiene and comfortable surroundings, with emphasis on provision of dental services for children.

The Group intends to open more dental centres to meet the growing demands for such services. This will be carried through organic growth, merger and acquisitions, joint ventures as well as partnerships.




