

## SPECIAL DIVIDEND FY2019

- (iv) Subject to shareholders' approval at the Adjourned AGM to be held on 11 May 2020, the payment of the Special Dividend of SGD0.01 per Share will be made on 20 May 2020 (Payment Date).
