FINANCIAL UPDATE FOR THE FINANCIAL YEAR ENDED 31 DECEMBER 2015

The Board of Directors of Global Palm Resources Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) wishes to announce that, following a preliminary review of the unaudited financial statements for the financial year ended 31 December 2015 (“**FY2015**”), the Group is expected to report a net profit after tax which will be substantially lower than that of the preceding financial year ended 31 December 2014.

The lower net profit after tax is primarily attributable to the decrease in the sales revenue and the average selling price of crude palm oil and palm kernel.

The Group is still in the process of finalizing its unaudited financial results for FY2015. Further details of the performance of the Group will be disclosed in its unaudited financial statements announcement for FY2015, which is expected to be released on or before 27 February 2016.
