### **BOUSTEAD SUBSIDIARY AWARDED CONTRACT FOR ICONIC SURBANA JURONG CAMPUS IN SINGAPORE**

**Singapore, 18 January 2019**

Boustead Singapore Limited ("Boustead" or "the Company") is pleased to announce that Surbana Jurong Private Limited ("Surbana Jurong") has awarded a contract worth over S\$200 million to the wholly-owned design-and-build business unit of Boustead's separately listed 53%-owned subsidiary, Boustead Projects Limited ("Boustead Projects"). Under the contract, Boustead Projects will build Surbana Jurong Campus, an integrated advanced development and global headquarters for the Surbana Jurong Group to be located at the 600-hectare Jurong Innovation District in Singapore. The contract represents Boustead Projects' largest private sector project to date.

The award of the latest contract has raised the Boustead Group's order book backlog to approximately S\$860 million (unrecognised project revenue remaining at the end of September 2018 plus the total value of new orders secured since then).

The above contract is not expected to have a material impact on the profitability, earnings per share ("EPS") and net tangible asset ("NTA") value per share of the Boustead Group in the current financial year ending 31 March 2019. However, it is expected to have a positive material impact on the Boustead Group's profitability and EPS for the financial years ending 31 March 2020 and 31 March 2021.
