Dr. Stephen Riady holds all the shares in Lippo Capital Group Limited, which is the holding company of Lippo Capital Holdings Company Limited ("LCH"). LCH is an intermediate holding company of Pacific Landmark Holdings Limited ("Pacific Landmark"). Pacific Landmark and Admiralty Station Management Limited jointly hold Lippo ASM Asia Property Limited ("LAAPL"). LAAPL is the indirect holding company of Treasure International Holdings Pte. Ltd. ("Treasure International"). Treasure International has a direct interest in 1,429,514,500 Shares (the "OUE Lippo Shares"). Accordingly, Dr. Stephen Riady has a deemed interest in the OUE Lippo Shares in which Treasure International has an interest. As a result of the Private Placement, the total number of Shares in issue has increased and the percentage of shareholding interest of Dr. Stephen Riady in the Shares has decreased, notwithstanding that the number of OUE Lippo Shares remains unchanged.
