StarHub is an independently managed Temasek portfolio company.

Temasek is filing this notification form to report a change in the percentage level of deemed interest from 7.74% to 9.83% due to the allotment and issue of 26,315,790 new shares to StarHub at a price of S\$0.57 per share pursuant to a placement agreement.

StarHub holds 114,315,790 shares of mm2. StarHub is a subsidiary of Asia Mobile Holdings Pte. Ltd. which is a subsidiary of Asia Mobile Holding Company Pte. Ltd. which is a subsidiary of STT Communications Ltd which is a subsidiary of Singapore Technologies Telemedia Pte Ltd ("STT") which is a subsidiary of Temasek.

STT and StarHub are independently managed Temasek portfolio companies. Temasek is not involved in their business or operating decisions, including those regarding StarHub's position in the shares of mm2.
