1. Issuance of the Tranche 1 Notes

The Board of Directors (the "**Board**") of Magnus Energy Group Ltd. ("the **Company**") wishes to announce that an aggregate amount of S\$1,000,000 of the Tranche 1 Notes have been duly issued to the Subscriber as at 24 November 2014 in accordance with the terms and conditions of the Notes Issue.

The Company will make further announcements on the utilisation of the net proceeds from the Notes Issue as and when the proceeds are materially disbursed.

2. Allotment and issue of Shares pursuant to the conversion of the Tranche 1 Notes

The Floating Conversion Price of S\$0.0072 was determined by taking 90% of the of the average of the traded volume weighted average prices per share for any three (3) consecutive Trading Days as selected by the Subscriber during the 30 Trading Days immediately preceding the relevant Conversion Notice dated, 24 November 2014.
