**ISSUE AND ALLOTMENT OF NEW ORDINARY SHARES PURSUANT TO THE EXERCISE OF SHARE OPTIONS UNDER THE MCE SHARE OPTION SCHEME 2014**

The board of directors (the “**Board**”) of Metal Component Engineering Limited (the “**Company**”) refers to the Company’s announcements dated (i) 27 June 2018, in relation to the grant of share options pursuant to the MCE Share Option Scheme 2014 (“**2014 Scheme**”), and (ii) 16 June 2021, in relation to the receipt of approval in-principle from the Singapore Exchange Securities Trading Limited for the listing and quotation of new shares pursuant to the 2014 Scheme.

The Board wishes to announce that the Company had, on 9 July 2021, issued and allotted an aggregate of 495,000 new ordinary shares in the capital of the Company (“**New Shares**”) pursuant to the exercise of 495,000 options granted under the 2014 Scheme, at the exercise price of S\$0.034 per New Share.

The New Shares rank *pari passu* in all respects with the existing issued ordinary shares in the capital of the Company (“**Shares**”), save that they shall not rank for any dividends, rights, allotments, distribution or entitlement, the record date of which falls on or prior to the date of issue of the New Shares. The New Shares are expected to be listed and quoted on Catalist on or around 13 July 2021 and trading of the New Shares will commence with effect from 9.00 a.m. on 13 July 2021.

Following the issuance of the New Shares, the total number of issued Shares has increased from 403,721,526 Shares to 404,216,526 Shares.
