Both Lifeline and Arona are companies wholly owned by Thomas. Therefore, Thomas is deemed interested in all of the shares held by Lifeline and Arona pursuant to Section 4(5) of the SFA.
- (2) 1,472,353,150 shares are held in the name of CGS-CIMB Securities (Singapore) Pte Ltd.
- (3) ~~1,200,000~~ **20,200,000** of the **604,784,471** shares are held ~~separately~~ in the name of Philip Securities Pte Ltd.
