## ANNOUNCEMENT

# ANNUAL GENERAL MEETING TO BE HELD ON 22 APRIL 2022

- 1. <u>Background</u>: Ascott Residence Trust Management Limited, as manager of Ascott Real Estate Investment Trust, and Ascott Business Trust Management Pte. Ltd., as trustee-manager of Ascott Business Trust, (collectively, the "**Managers**") refer to:
  - (a) the COVID-19 (Temporary Measures) Act 2020 which enables the Minister for Law by order to prescribe alternative arrangements for listed entities in Singapore to, *inter alia*, conduct general meetings, either wholly or partly, by electronic communication, video conferencing, teleconferencing or other electronic means;
  - (b) the COVID-19 (Temporary Measures) (Alternative Arrangements for Meetings for Companies, Variable Capital Companies, Business Trusts, Unit Trusts and Debenture Holders) Order 2020 (the "Order"), which sets out the alternative arrangements in respect of, *inter alia*, general meetings of real estate investment trusts; and
  - (c) the Joint Statement by Accounting and Corporate Regulatory Authority, Monetary Authority of Singapore and Singapore Exchange Regulation of 13 April 2020 (and subsequently updated on 27 April 2020, 22 June 2020, 1 October 2020 and 4 February 2022) which provides guidance on the conduct of general meetings amid the evolving COVID-19 situation.
- 2. Date, time and conduct of AGM: The Managers wish to announce that pursuant to the Order, the annual general meeting (the "AGM") of the holder of stapled securities in Ascott Residence Trust ("ART", and the stapled securities, the "Stapled Securities,", and the holders of Stapled Securities, the "Stapled Securityholders") will be convened and held by electronic means, on Friday, 22 April 2022 at 10.00 a.m. (Singapore Time).

The Managers' Chairman, Mr Tan Beng Hai, Bob, and Chief Executive Officer, Ms Beh Siew Kim, will conduct the proceedings of the AGM.

- 3. <u>Notice of AGM and Proxy Form</u>: The Notice of AGM dated 31 March 2022 (the "Notice of AGM") and Proxy Form will be sent to Stapled Securityholders solely by electronic means via publication on ART's website at <u>https://investor.ascottresidencetrust.com/agm\_egm.html</u>, and on the SGX website at <u>https://www.sgx.com/securities/company-announcements</u>. Printed copies of these documents will <u>not</u> be sent to Stapled Securityholders.
- 4. <u>No personal attendance at AGM</u>: As a precautionary measure due to the current COVID-19 situation in Singapore, to keep physical interactions and COVID-19 transmission risk to a minimum, the Managers are not providing for physical attendance by Stapled Securityholders at the AGM.

The AGM will be conducted virtually. To facilitate engagement with Stapled Securityholders, the Managers will implement real-time remote electronic voting (live voting) and real-time electronic communications (live Q&A) at the AGM.

- 5. <u>Alternative arrangements for participation in the AGM</u>: Stapled Securityholders may participate at the AGM by:
  - (i) observing and/or listening to the AGM proceedings via live audio-visual webcast or live audio-only stream;
  - (ii) submitting questions to the Chairman of the AGM in advance of, or live at, the AGM; and
  - (iii) voting at the AGM (a) live by the Stapled Securityholder or his/her/its duly appointed proxy(ies) (other than the Chairman of the AGM) via electronic means; or (b) by appointing the Chairman of the AGM as proxy to vote on the Stapled Securityholder's behalf at the AGM.

Alternative arrangements relating to attendance at the AGM via electronic means (including arrangements by which the meeting can be electronically accessed via live audio-visual webcast or live audio-only stream), submission of questions to the Chairman of the AGM in advance of, or live at, the AGM, addressing of substantial and relevant questions in advance of, or live at, the AGM, and voting at the AGM (i) live by the Stapled Securityholder or his/her/its duly appointed proxy(ies) (other than the Chairman of the AGM) via electronic means; or (ii) by appointing the Chairman of the AGM as proxy to vote on the Stapled Securityholder's behalf at the AGM, are set out in the Notice of AGM.

In particular, CPF and SRS investors should note that they (i) may vote live via electronic means at the AGM if they are appointed as proxies by their respective CPF Agent Banks or SRS Operators, and should contact their respective CPF Agent Banks or SRS Operators if they have any queries regarding their appointment as proxies; or (ii) may appoint the Chairman of the AGM as proxy to vote on their behalf at the AGM, in which case they should approach their respective CPF Agent Banks or SRS Operators to SRS Operators to submit their votes by **5.00 p.m. on Monday**, **11 April 2022**, being seven working days before the date of the AGM. For avoidance of doubt, CPF and SRS investors will not be able to appoint third party proxy(ies) (i.e., persons other than the Chairman of the AGM) to vote live at the AGM on their behalf.

**Persons who hold Stapled Securities through relevant intermediaries:** Persons who hold Stapled Securities through relevant intermediaries (as defined in the Notice of AGM), other than CPF and SRS investors, and who wish to participate in the AGM by (i) observing and/or listening to the AGM proceedings via live audio-visual webcast or live audio-only stream; (ii) submitting questions to the Chairman of the AGM in advance of, or live at, the AGM; and/or (iii) voting at the AGM (a) live via electronic means by being appointed as proxy by their relevant intermediary; or (b) by appointing the Chairman of the AGM as proxy to vote on their behalf at the AGM, should contact the relevant intermediary through which they hold such Stapled Securities as soon as possible in order to make the necessary arrangements for them to participate in the AGM.
