ARA Holdings holds 100% of the shares of ARA Investment (Cayman) Limited, which holds 100% of the shares of ARA Asset Management Limited, which in turn holds 100% of the shares of ARA Logistics (Holdings) Pte. Ltd.

LOGOS Units No. 1 Ltd. holds units in ARA LOGOS Logistics Trust and is a subsidiary of LOGOS China Investments Limited, which is in turn a subsidiary of ARA Logistics Venture I Limited. ARA Logistics Venture I Limited is a subsidiary of ARA Logistics Partners Limited, which is in turn a subsidiary of ARA Logistics (Holdings) Pte. Ltd.

AVICT Dragon was previously a substantial unitholder of ARA LOGOS Logistics Trust by virtue of its deemed interest in the units in ARA LOGOS Logistics Trust held by LOGOS Units No. 1 Ltd.

Following the sale by AVICT Dragon of all its shares in ARA Holding, AVICT Dragon has ceased to be a substantial unitholder of ARA LOGOS Logistics Trust.

The percentage of unitholding set out above is calculated on the basis of 1,088,684,835 units in ARA LOGOS Logistics Trust.

Aviation Industry Corporation of China ("AVIC") holds more than 20 per cent. of the voting rights of AVIC Capital.

AVIC is wholly-owned by the Central State-Owned Assets Supervision and Administration Commission of the People's Republic of China.

By virtue of the above, AVICT Phoenix, AVIC Trust, China Aviation, AVIC Capital, and AVIC have each also ceased to be a substantial unitholder of ARA LOGOS Logistics Trust.


