AHTM has sold the 981,351 stapled securities that it is entitled to receive as payment of the base component of its management fee to Ascendas Land International Pte Ltd ("ALI", an indirect, wholly-owned subsidiary of Ascendas-Singbridge Pte. Ltd.) and has, in connection with the sale, directed that such stapled securities be issued directly to ALI instead of AHTM.
