Pursuant to Rule 704(31) of the Listing Manual of the Singapore Exchange Securities Trading Limited, CapitaLand China Trust Management Limited (the "**Manager**"), as manager of CapitaLand China Trust ("**CLCT**"), wishes to announce that HSBC Institutional Trust Services (Singapore) Limited, in its capacity as trustee of CLCT (the "**Borrower**") has on 9 December 2024 entered into a facility agreement (the "**Facility Agreement**"), which contains a prepayment event (the "**Prepayment Event**") if CLCT ceases to be managed by the Manager, any successor manager that is a direct or indirect wholly owned subsidiary of CapitaLand Investment Limited, or any other entity as may be agreed between the lender under the Facility Agreement and the Borrower.

If the Prepayment Event occurs and the Borrower fails to pay the outstanding amounts due and payable under the Facility Agreement in accordance therewith, it may trigger cross defaults under other facilities, debt issues and borrowings of CLCT and/or its subsidiaries (collectively, together with the facilities under the Facility Agreement, "**Borrowings**"). The aggregate level of Borrowings which are outstanding and that may be affected is approximately S\$1.8 billion (excluding interest) as at 9 December 2024.

As at the date of this announcement, the Prepayment Event has not occurred.
