The REIT Manager had, on 25 March 2025, launched an equity fund raising by way of a private placement ("Private Placement"). A total of 105,264,000 new Units ("New Units") were issued on 4 April 2025 under the Private Placement at an issue price of S\$2.0900 per New Unit.
