ENTRY INTO A LOAN AGREEMENT AS AN INTERESTED PERSON TRANSACTION

1. INTRODUCTION

The board of directors (the "Board" or the "Directors") of Shanghai Turbo Enterprises Ltd. (the "Company", and together with its subsidiaries, the "Group") wishes to announce that the Company's wholly-owned subsidiary, Changzhou 3D Technological Complete Set Equipment Co., Ltd ("CZ3D" the "Lender"), has on 21 May 2021, entered into a loan agreement (the "Loan Agreement") with Mr Liu Ming (a major shareholder, who is holding the 8,240,000 shares of the Company, the "Borrower"). Pursuant to the Loan Agreement, the Lender has agreed to grant a loan in the principal amount of up to RMB4 million in aggregate (the "Aggregate Loan Amount") to the Borrower, subject to the terms and conditions set out in the Loan Agreement. A summary of the principal terms of the Loan Agreement is set out in paragraph 2 of this announcement.

2. PRINCIPAL TERMS OF THE LOAN AGREEMENT

Bank loan from Bank Of Communications To CZ3D	In the beginning of year 2021, as the Lender needed to take an additional bank loan as working capital to keep its business going, it had applied for a business loan amounting to RMB8 million from the Bank of Communications ("BOC"), WuJin Branch in ChangZhou, JiangSu, China. Despite the recommendations of credible references secured by the Lender's General Manager, BOC requested the Lender to provide collateral for the loan of RMB8 million.						
	As the Lender's right-of-use assets certificate has been mortgaged to JiangNan Bank in Zhong Lou District, ChangZhou, JiangSu, China, the Lender could only request the Borrower to put up his personal asset as the collateral.						
	The Borrower has then put forth his private residential property with an evaluated valuation of RMB4.4 million as collateral and secured the bank loan of RMB4.4 million from BOC.						
	In addition, the Lender's General Manager ("the GM"), who is holding 3,051,527 shares of the Company, has provided his personal guarantee to secure another BOC bank loan amounting to RMB3.6 million for the Lender.						
	Based on the terms and conditions mandated by BOC, the Borrower and the GM have signed the loan agreement with BOC for the total bank loan amounting to RMB8 million.						
	The Board of the Lender had held a Board Meeting on 26 March 2021 and approved the application of Ioan of RMB8 million from BOC.						
	The Borrower has obtained a non-secured loan from the Lender on 21 May 2021, as the Board of the Lender recognizes that the efforts that the Borrower has pledged his private residential property as collateral to secure the RMB4.4 million loan from BOC for the Lender.						
	The total Agreeable Aggregate Loan amounting to RMB8 million will be used solely as working capital of the Lender.						
	In addition to the above loan amount of RMB8 million, the Lender has on 31 March 2020 already obtained a working capital loan of RMB4.4 million from BOC for loan period from 31 Mach 2020 to 18 March 2021 at interest rate of 4.35% per annum.						
	The Lender has also obtained a working capital loan of RMB1.6 million from BOC on 31 Mach 2020 for loan period from 31 March 2020 to 30 March 2021 at interest rate of 4.35% per annum.						
	Currently the Lender has a RMB2 milion credit line not drawn from BOC.

3. RATIONALE FOR THE LOAN

The Loan will be utilised by the Borrower for his personal use as he had pledged his person residential property as collateral and secured the bank loan of RMB4.4 million from BOC.

Having reviewed the above, the Board is of the view that the Loan to the Borrower is in the interests of the Company and CZ3D. The Audit Committee shall review the terms, rationale and benefits of the Loan to determine if the Loan continues to be in the interests of the Company and CZ3D or if CZ3D should undertake a Prepayment of the Outstanding Principal Amount of the Loan.

4. DETAILS OF THE LENDER

The Lender, Mr Liu Ming, is a major shareholder who holding 8,240,000 shares of the Company. As at 21 May 2021, the date of the Loan Agreement, the Lender has a direct and deemed interest in approximately 29.998% of the share capital of the Company respectively and is, therefore, one of the major shareholder of the Company. Accordingly, the Lender is deemed to be an "interested" person and the entry into the Loan Agreement is an "interested person transaction" for the purposes of Chapter 9 of the Listing Manual of the Singapore Exchange Securities Trading Limited ("SGX-ST").

5. CHAPTER 9 OF THE LISTING MANUAL OF SGX-ST

Based on the latest audited consolidated financial statements of the Company for the financial year ended 31 December 2019, the Group's latest audited net tangible assets ("Group NTA") is approximately RM93.84 million as at 31 December 2019.

There are no interested person transactions entered into by the Group with the Borrower and his associates (excluding transactions which are less than S\$100,000 and the Loan Agreement which is the subject of this announcement) for the current financial year commencing 1 January 2020 up to the date of this announcement.

The Loan of RMB4 million provided to Mr Liu Ming and the interest payable of RMB106,307 are approximately 4.376% of the Group NTA. Accordingly, no approval of the shareholders of the Company ("Shareholders") is required to be sought for the Loan pursuant to Rule 906(1)(b) of the Listing Manual of SGX-ST. This announcement is being made by the Company pursuant to Rule 905(2) of the Listing Manual of SGX-ST as the aforesaid percentage figure exceeded the relevant threshold of 3.0%.

For the financial year commencing 1 January 2020 up to the date of this announcement, the aggregate value of all transactions entered into by the Group with all interested persons (excluding transactions which are less than S\$100,000 and the Loan Agreement which is the subject of this announcement) is stated as above.

6. AUDIT COMMITTEE STATEMENT

The Audit Committee of the Company, having considered, the terms, rationale and benefits of the Loan, is of the view that the Loan is on normal commercial terms and is not prejudicial to the interests of the Company and its minority Shareholders.

7. INTERESTS OF DIRECTORS AND CONTROLLING SHAREHOLDERS

Save as disclosed in this announcement, none of the Directors or controlling Shareholders of the Company and their respective associates has any interest, direct or indirect, in the Loan Agreement (other than through their respective shareholdings in the Company, if any).
