Disposal of 1,078,600 ordinary shares in the Company (each an "ISDN Share") by NTCP SPV VI ("NTCP") on 11 September 2026. Following such disposal, NTCP holds 29,541,542 ISDN Shares.

Novo Tellus PE Fund 2, L.P. ("NT Fund 2") is the owner of 100% of the shares in NTCP and is therefore deemed interested in the ISDN Shares held by NTCP.

New Earth Group 2 Ltd ("NEG 2") is the general partner of NT Fund 2. Accordingly, NEG 2 has deemed interests in the ISDN Shares held by NTCP, which NT Fund 2 is deemed interested in.

Keith Hsiang-Wen Toh ("Mr Toh") is entitled to exercise or control the exercise of not less than 20% of the votes attached to the voting shares in NEG 2. Accordingly, Mr Toh has deemed interests in the ISDN Shares held by NTCP, which NT Fund 2 and NEG 2 are deemed interested in.
