This announcement contains important information of interest to the beneficial owners of the Shares in the Sub-Funds. All depositaries, custodians and other intermediaries receiving this announcement are requested to promptly forward this announcement to such beneficial owners.

In accordance with paragraph 2.6 of the prospectus of the Fund, the Fund wishes to inform you that the Manager of the Sub-Funds, Lyxor International Asset Management S.A.S, and Lyxor Asset Management S.A.S will merge with Amundi Asset Management S.A.S ("**Amundi**") on June 1st, 2022 (the "**Effective Date**"). Pursuant to the merger, Amundi will become the Manager of the Sub-Funds on the Effective Date.

Amundi is a management company authorised by the French Autorité des marchés financiers ("**AMF**") on July 1st, 2004 under the number GP-04000036 and an Alternative Investment Fund Manager duly authorised by the AMF on May 15<sup>th</sup>, 2014 under the same reference number.

For the avoidance of doubt, the change in the Manager of the Sub-Funds will not result in any changes to the other service providers of the Fund or the Sub-Funds. In addition, there will be no change to the investment objective, terms, fees or any other characteristics of the Sub-Funds, and no costs or fees arising from the merger will be borne by the Fund.
