PAYMENT OF BASE FEE BY WAY OF ISSUE OF UNITS IN KEPPEL INFRASTRUCTURE TRUST

Keppel Infrastructure Fund Management Pte. Ltd. ("**KIFM**" or "**KIT Trustee-Manager**"), as trustee-manager of Keppel Infrastructure Trust ("**KIT**"), wishes to announce that 1,359,209 units ("**Base Fee Units**") in KIT ("**Units**") have been issued today at a price of S\$0.4836 per Unit, as payment of 4.5% of the aggregated base fee billed to KIT Trustee-Manager for the period from 1 July 2025 to 31 December 2025.

The issue price per Base Fee Unit is the volume weighted average price for a Unit for all trades done on the Singapore Exchange Securities Trading Limited (the "**SGX-ST**") in the ordinary course of trading on the SGX-ST for the last five trading days (that is, the last five full market days when the Units are traded on the SGX-ST) of the period ended 31 December 2025.

The payment of the base fee and the manner of such payment are provided for in the trust deed dated 5 January 2007 constituting KIT, as amended and restated by an Amendment and Restatement Deed dated 18 May 2015, as supplemented by a First Supplemental Deed dated 17 April 2018, as supplemented by a Second Supplemental Deed dated 28 April 2022, and as further supplemented by a Third Supplemental Deed dated 18 April 2023 (the "**Trust Deed**"). It is provided in the Trust Deed that the KIT Trustee-Manager is entitled to receive its base fee in a combination of Units and cash in such proportions as it may elect. For the period from 1 July 2025 to 31 December 2025, the KIT Trustee-Manager has elected to receive:

- (i) 4.5% of its base fee in the form of Units; and
- (ii) 95.5% of its base fee in cash.

As at the date of this announcement, the KIT Trustee-Manager holds 1,359,209 Units, representing approximately 0.02% of the total number of 6,086,347,124 issued Units in KIT.
