Frasers Property Limited ("FPL") holds a 100% direct interest in each of FCAM and Frasers Property Retail Trust Holdings Pte. Ltd. ("FPRTH"). FCAM and FPRTH holds units in FCT. FPL therefore has a deemed interest in the units in FCT in which each of FCAM and FPRTH has an interest, by virtue of Section 4 of the Securities and Futures Act (Chapter 289) of Singapore ("SFA").

MMC together with Risen Mark Enterprise Ltd. and Golden Capital (Singapore) Limited collectively holds a greater than 20% interest in Thai Beverage Public Company Limited ("ThaiBev");

- ThaiBev holds a 100% direct interest in International Beverage Holdings Limited ("IBHL");
- IBHL holds a 100% direct interest in InterBev Investment Limited ("IBIL");
- IBIL holds a greater than 20% interest in FPL;
- FPL holds a 100% direct interest in each of FCAM and FPRTH; and
- FCAM and FPRTH hold units in FCT.
