### PRESS RELEASE ISSUED BY DOCUMENT SECURITY SYSTEMS, INC. IMPACT BIOMEDICAL, INC. INITIATES BIOPLASTICS RESEARCH COLLABORATION

The Board of Directors (the “**Board**”) of Singapore eDevelopment Limited (Stock Code: 40V) (the “**Company**”) wishes to announce that its related company, Document Security Systems, Inc. (“**DSS**”), has issued a press release titled “*Impact BioMedical Initiates Bioplastics Research Collaboration with One of World’s Largest Plastic Manufacturers*” (the “**Press Release**”) on 8 September 2020 (Eastern Time).

A copy of the Press Release issued by DSS is attached to this announcement.
