Temasek is filing this notification form to report a change in deemed interest from 55.99% to 56.03% of voting shares ("Shares") of the Listed Issuer as a result of the purchase of 1,080,000 Shares by Dymon Asia Multi-Strategy Master Fund ("Dymon Fund"). (the "Transaction").

Temasek's deemed interest in the Shares of the Listed Issuer arises from the interest held by Singapore Airlines Limited ("SIA") and Dymon Fund.

(A) Temasek's deemed interest through SIA 55.736%

(B) Temasek's deemed interest through Dymon Fund 0.299%

(i) Dymon Fund holds 0.299% of the Shares.

(ii) Dymon Fund comprises a master fund and feeder fund.

(iii) Temasek owns 100% of a passive limited partner of the feeder fund which is deemed to have an interest in the Shares pursuant to Regulation 13(5) of the Securities and Futures (Disclosure of Interests) Regulations 2012. Temasek is therefore deemed, pursuant to Section 4(4) of the Securities and Futures Act, to have a deemed interest in the limited partner's interest in the Shares.
