OFFICIAL OPENING OF SHENYANG SHENHE AOXIN STOMATOLOGY POLYCLINIC CO., LTD

Singapore, 30 May 2018 – Catalyst-listed **Aoxin Q&M Dental Group Limited** (the “**Company**” and together with its subsidiaries, the “**Group**”), a leading provider of private dental services, distributor of dental equipment and supplies as well as provider of laboratory services in Liaoning Province, Northern PRC, is pleased to announce the official opening of its new dental polyclinic, Shenyang Shenhe Aoxin Stomatology Polyclinic Co., Ltd (the “**Polyclinic**”).

The Polyclinic is located in the city of Shenyang, Shenhe District, and occupies a unit on the 6th storey of Kaisa Commercial Centre. Kaisa Commercial Centre is a newly-built shopping mall situated along Youth Avenue, one of the busiest streets in Shenyang City. The opening of the Polyclinic coincides with the opening of the shopping mall, which takes up eleven stories (including 4 underground floors) and offers a diverse tenant mix of retail, food & beverage, luxury brands and supermarket, amongst others.

The Polyclinic provides patients with a welcoming environment and state-of-the-art dental technology. With a floor area of approximately 300m², the Polyclinic includes 6 dental chairs and provides comprehensive dental services for adults and children.

This is the first polyclinic, through organic expansion, within the Group to be located in a shopping mall, and marks a milestone in the Group’s strategy to expand its dental business to new locations. The Polyclinic is also one of the first within the Group to be set up as a new facility with dentists and nurses transferred from other entities within the Group, compared to the existing strategy of acquiring clinics or hospitals along with its dentists and nurses. The Group will continue to pursue growth through a combination of acquisitions and setting up of new polyclinics and hospitals in locations with high traffic volume.
