("Venice Concepts") entered into a sale and purchase agreement ("SPA") with JAG Capital Holdings Sdn Bhd ("Seller"), pursuant to which Venice Concepts had agreed to purchase from the Seller 85,170,779 Shares ("Sale Shares"), representing approximately 28.00% of the total number of Shares (excluding treasury shares) for an aggregate consideration of S\$38,326,850.55. The Sale Shares were credited on 1 August 2025 into the sub-account maintained by Venice Concepts with its Depository Agent, RHB Bank Nominees Pte. Ltd.
