REPLY TO SGX-ST QUERY REGARDING TRADING ACTIVITY

The Board of Directors (the "**Board**") of Cordlife Group Limited (the "**Company**") refers to the queries from the Singapore Exchange Securities Trading Limited ("**SGX-ST**") on 13 July 2018 regarding the unusual price movements in the price of the Company's shares on 13 July 2018 (the "**Queries**") and wishes to respond to the Queries as follows:

Question 1:

Are you (the issuer) aware of any information not previously announced concerning you, your subsidiaries or associated companies which, if known, might explain the trading? Such information may include events that are potentially material and price sensitive, such as discussions and negotiations that may lead to joint ventures, mergers, acquisitions or purchase or sale of a significant asset. You may refer to paragraph 8 in Appendix 7.1 of the Mainboard Rules for further examples. If yes, the information shall be announced immediately.

Company's response to Question 1:

The Company constantly explores and reviews corporate development opportunities which are in line with its corporate growth strategy and is currently in confidential and non-binding discussions in relation to the structuring of possible transactions. No definitive agreements have been signed at this time and there is no certainty that any of them will materialise.

The Company will keep shareholders informed if there are any material developments by making the appropriate announcements in compliance with the listing rules of the SGX-ST.

In the meantime, shareholders of the Company are advised to exercise caution when dealing in shares of the Company.

Question 2:

Are you aware of any other possible explanation for the trading? Such information may include public circulation of information by rumours or reports.

Company's response to Question 2:

The Company is not aware of any other possible explanation for the trading.

Question 3:

Can you confirm your compliance with the listing rules and, in particular, Mainboard Rule 703?

Company's response to Question 3:

The Board confirms that the Company is in compliance with the listing rules and, in particular, Rule 703 of the Listing Manual of the SGX-ST.
