## **RE-DESIGNATIONS OF DIRECTORS AND RECONSTITUTION OF BOARD**

## 1. Re-designations of Directors

The Board of Directors (the "**Board**") of Kitchen Culture Holdings Ltd. (the "**Company**" and together with its subsidiaries, the "**Group**") wishes to announce the re-designations of the following members of the Board with effect from 10 November 2022:

- (i) The re-designation of Mr Lau Kay Heng from Vice-Chairman and Non-Executive Director of the Company to Non-Executive Non-Independent Chairman of the Board; and
