**SUCCESSFUL CLOSE OF MONEYMAX'S SERIES 014 DIGITAL SECURITY TOKENS TO BE LISTED ON THE "ADDX" SECURITY TOKEN TRADING PLATFORM UNDER ITS S\$100,000,000 UNSECURED COMMERCIAL PAPER PROGRAMME (THE "PROGRAMME")**

The board of directors (the "**Board**") of MoneyMax Financial Services Ltd. (the "**Company**") refers to the Company's announcements dated 9 January 2023, 24 September 2024 and 28 May 2025 in relation to the Programme (the "**Announcements**"). The Board is pleased to announce that the offering of the Series 014 Tokens has closed at 12.00 p.m. (Singapore time) on 12 June 2025 and the Company has successfully raised S\$60.26 million in gross proceeds from the issuance of the Series 014 Tokens. The Series 014 Tokens will be listed on the ADDX Exchange on 13 June 2025.

The subscribers of the Series 014 Tokens include: (i) Dato' Sri Dr. Lim Yong Guan, the Executive Chairman, Chief Executive Officer and a controlling shareholder of the Company ("**Dato' Sri Dr. Lim**"); (ii) Mr. Lim Yong Sheng, the Non-Executive Director and a controlling shareholder of the Company; (iii) Mdm. Lim Liang Eng, a controlling shareholder of the Company and a sister of Dato' Sri Dr. Lim; (iv) Mdm. Lim Liang Cheng, a sister of Dato' Sri Dr. Lim; (v) Mdm. Tan Yang Hong, the Chief Operating Officer of the Company and the spouse of Dato' Sri Dr. Lim; (vi) Mr. Lim Yeow Hua, an Independent Non-Executive Director of the Company ("**Mr. Lim**") and (vii) Mdm. Yeh Siew Ho, the spouse of Mr. Lim (collectively, the "**Series 014 Related Parties**"). The Series 014 Related Parties had collectively subscribed for S\$26.90 million, representing 44.64% of the Series 014 Tokens.

The Company will make further announcements as appropriate, if and when there are material developments in relation to the Programme and the issuance of the Series 014 Tokens by the Company which warrant disclosure.
