NTEGRATOR SECURES S\$20.8 MILLION¹ SUPPLY CONTRACT FROM VIETTEL

- *For the supply of high-performance batteries to Viettel, Vietnam's largest mobile network operator*
- *Contract is the sixth and single largest supply contract placed to-date by Viettel under a frame contract signed in 2015*
- *Order slated for delivery by end 2016*

Singapore, October 26, 2016 – Ntegrator International Ltd (“Ntegrator” or “the Group”), a leading regional communications network specialist and systems integrator, is pleased to announce that it has secured a supply contract worth US\$15.0 million (approximately S\$20.8 million based on an exchange rate of 1 USD: 1.39 SGD).

The contract is awarded by Vietnam's largest mobile network operator, Viettel, for the supply of high-performance batteries. The new order marks the sixth and the largest order awarded to Ntegrator to-date under a frame contract entered into between Ntegrator and Vietnam in January 2015, whereby Ntegrator was recognised as one of the main suppliers of the Narada brand of batteries to Viettel on an ongoing basis.

The abovementioned contract is slated for delivery by end 2016 and is expected to contribute positively to the Group's financial performance for the financial year ending December 31, 2016 (“FY2016”), subject to timely completion of the project and effective cost management.
