The board of directors (the "**Board**" or "**Directors**") of ZICO Holdings Inc. (the "**Company**", and together with its subsidiaries and associates, the "**Group**") is pleased to announce that, following the Company's revised additional listing application on 13 April 2022 for a fresh listing and quotation notice (the "**LQN**") from the Singapore Exchange Securities Trading Limited (the "**SGX-ST**") in respect of the 22,000,000 Placement Shares, the Company has on 20 April 2022 received the LQN from the SGX-ST for the listing and quotation of the Placement Shares on the Catalist Board of the SGX-ST.

As disclosed in the Previous Announcements, 22,000,000 Placement Shares will be issued to the placee, Dynac Sdn. Bhd., at the issue price of S\$0.11 per Placement Share pursuant to the Placement Agreement.

The Company may proceed with the listing and quotation of the Placement Shares subject to compliance with the SGX-ST's listing requirements.

Shareholders should note that the LQN is not to be taken as an indication of the merits of the Placement, the Placement Shares, the Company, its subsidiaries and their securities. The Placement Shares are required to be placed out within seven (7) market days from the date of the LQN.

The Company will make the necessary announcements upon the allotment and issuance of the Placement Shares to the Placee, as appropriate.
