Temasek Holdings (Private) Limited ("Temasek") does not have any direct interest in the voting shares of Tiger Airways Holdings Limited (the "Listed Issuer").

Temasek is filing this notification form to report a change in deemed interest from 40% to 55.81% of voting shares of the Listed Issuer as a result of the conversion by Singapore Airlines Limited ("SIA") of the principal amount of S\$202,647,692.69 or 189,390,367 non-voting perpetual convertible capital securities ("PCCS") issued by the Listed Issuer pursuant to a non-renounceable preferential offering of the PCCS to the Listed Issuer's shareholders which completed on 22 April 2013 ("Transaction"). The adjusted conversion price is S \$0.565.

Temasek's deemed interest in the voting shares of the Listed Issuer arises from the direct interest held by SIA. SIA has a direct interest in 55.81% of voting shares of the Listed Issuer after the Transaction. Temasek owns more than 50% of SIA.

SIA is an independently managed Temasek portfolio company. Temasek is not involved in its business or operating decisions, including those regarding its positions in the voting shares of the Listed Issuer.
