Ever Glory United Secures More Than S\$168 Million in New Contracts, Lifting Order Book Beyond S\$1 Billion

- **Secured more than S\$168 million in new contracts**
- **Total order book crosses the S\$1 billion mark, providing earnings visibility through 2028 and beyond**
- **New contracts secured since the start of 2026 now total approximately S\$400 million, sustaining the Group's growth momentum**

Singapore, 27 July 2026 – Ever Glory United Holdings Limited (the “**Company**”, and together with its subsidiaries, the “**Group**”) is pleased to announce that it has secured more than S\$168 million in new contracts, lifting the Group's total order book beyond S\$1 billion for the first time in its history.

The new wins include a subcontract for electrical works on a Defence Science and Technology Agency (“**DSTA**”) project. The Group has also secured mechanical and electrical works for commercial mixed developments, building on its earlier wins in Singapore's prime business districts and reflecting sustained private-sector demand for the Group's integrated M&E capabilities.

The order book provides the Group with significant earnings visibility through 2028 and beyond, with progressive financial contribution expected over the next two to three years, barring unforeseen circumstances.

Securing mechanical and electrical works on military infrastructure project and new commercial mixed development projects demonstrates the breadth of contracts we can now compete for and win.

With demand across Singapore’s construction sector expected to remain robust, we see a healthy pipeline of opportunities ahead. Our priority remains disciplined execution, converting this record order book into quality earnings and sustained value for our stakeholders.”

The Group's M&E engineering business began in 2018 through wholly-owned subsidiary, Sunbeam M&E Pte. Ltd., delivering comprehensive engineering solutions to public and private sector clients. Services include the supply and installation of air-conditioning and mechanical ventilation systems, electrical engineering systems, fire protection systems, plumbing, sanitary and gas systems, and integrated building services across residential, commercial, institutional and industrial projects in Singapore.

Strategic acquisitions have strengthened the Group's M&E capabilities. In February 2024, Ever Glory acquired Fire-Guard Engineering Pte. Ltd., an established firm with over 30 years of industry experience, enabling more integrated, in-house M&E solutions. The July 2025 acquisition of Guthrie Engineering (S) Pte. Ltd. further enhances scale, provides a larger order book, and the capacity to tender for larger, more complex projects.

Ever Glory diversified into property investment and development in 2023 through Ever Capital Pte. Ltd. Current projects include a freehold residential development in Geylang and a food factory development at Mandai Estate.
