## **IMPERIUM CROWN LIMITED AWARDED “AAAA” RATING FOR WONDER STONE PARK**

- ***The “AAAA” rating as a tourist site is granted by the Shandong Tourism Development Commission***

Singapore, 17 December 2018 – Imperium Crown Limited (the “**Company**” and collectively with its subsidiaries, the “**Group**”) is pleased to announce that it has been awarded the “AAAA” rating for the Wonder Stone Park by the Shandong Tourism Development Commission. As announced by the Company on 8 January 2018, the “AAAA” rating of the Wonder Stone Park was removed in 2017 and the Company has since been undertaking steps to regain the “AAAA” rating. Following a series of submissions to the Shandong Tourism Development Commission which had subsequently conducted its inspections, the Wonder Stone Park was officially recognised as an “AAAA” rating tourism site effective from 12 December 2018. The granting of the “AAAA” rating is not expected to have any material effect on the consolidated net tangible assets and earnings per share of the Company and the Group for the current financial year ending 30 June 2019.

Commenting on the Wonder Stone Park being awarded the “AAAA” rating, Mr Sun Bowen, the Group’s Executive Director remarked:

***“We are delighted that the Wonder Stone Park has been awarded the “AAAA” rating and it is testament of the effort put forth by our team. We are confident of building upon this achievement as we progressively roll out our development plans for the Wonder Stone Park.”***
