1. INTRODUCTION

The Board of Directors (the "**Board**") of T T J Holdings Limited (the "**Company**" and together with its subsidiaries, the "**Group**") refers to:

- (a) the COVID-19 (Temporary Measures) Act 2020 passed by Parliament on 7 April 2020 which enables the Minister for Law by order to prescribe alternative arrangements for listed companies in Singapore to, *inter alia*, conduct general meetings, either wholly or partly, by electronic communication, video conferencing, tele-conferencing or other electronic means;
- (b) the COVID-19 (Temporary Measures) (Alternative Arrangements for Meetings for Companies, Variable Capital Companies, Business Trusts, Unit Trusts and Debenture Holders) Order 2020 (the "**Relevant Order**") which was gazetted on 13 April 2020 and is deemed to have come into operation on 27 March 2020, and which sets out the alternative arrangements in respect of, *inter alia*, general meetings of companies; and
- (c) the joint statement released by the Accounting and Corporate Regulatory Authority ("ACRA"), the Monetary Authority of Singapore and Singapore Exchange Regulation ("SGX-ST") on 13 April 2020 (and subsequently updated on 27 April 2020, 22 June 2020 and 1 October 2020), which provides additional guidance on the conduct of general meetings during the Relevant Order Period.

2. DATE OF ANNUAL GENERAL MEETING

The Directors wish to inform Shareholders that the Company has today issued the Notice of Annual General Meeting ("**AGM**") dated 3 November 2021 ("**Notice of AGM**"). The AGM will be held by way of electronic means on 30 November 2021 at 2.30 p.m.

3. NO DESPATCH OF PRINTED COPIES OF ANNUAL REPORT 2021, NOTICE OF AGM, PROXY FORM AND LETTER TO SHAREHOLDERS IN RELATION TO THE PROPOSED RENEWAL OF THE SHARE PURCHASE MANDATE

In line with the provisions under the Relevant Order, no printed copies of the Annual Report 2021, Notice of AGM, proxy form and Letter to Shareholders in relation to the proposed renewal of share purchase mandate in respect of the AGM will be despatched to Shareholders.

Copies of the Annual Report 2021, Notice of AGM, proxy form and Letter to Shareholders in relation to the proposed renewal of the share purchase mandate have been uploaded on SGXNet and are now also available on the Company's website at the URL www.ttj.com.sg.

A Shareholder will need an internet browser and PDF reader to view these documents on SGXNet and the Company's website.

Shareholders are advised to read the Notice of AGM carefully in order to decide whether they should vote in favour of or against the ordinary resolutions, or to abstain from voting on the ordinary resolutions, to be tabled at the AGM.

4. NO ATTENDANCE AT AGM

Due to the current COVID-19 measures in Singapore, Shareholders will not be allowed to attend the AGM. Instead, alternative arrangements have been put in place to allow Shareholders to participate at the AGM by (a) watching the AGM proceedings via "live" webcast or listening to the AGM proceedings via "live" audio feed, (b) submitting questions in advance of the AGM, and/or (c) voting by proxy at the AGM. Please see paragraph 5 below for these alternative arrangements.

5. ALTERNATIVE ARRANGEMENTS

The following are the alternative arrangements which have been put in place for the AGM:

(a) "Live" webcast and "live" audio feed

The Chairman of the Meeting, Mr Lim Yian Poh, will conduct the proceedings of the AGM by way of electronic means. Shareholders will be able to watch these proceedings through a "live" webcast via their mobile phones, tablets or computers or listen to these proceedings through a "live" audio feed via telephone. In order to do so, Shareholders (including CPF or SRS investors) must follow these steps:

• Shareholders (including CPF or SRS investors) who wish to watch the "live" webcast or listen to the "live" audio feed must pre-register by 2.30 p.m. on 26 November 2021, at the URL <u>https://septusasia.com/ttj-agm2021-registration</u>.

Following the authentication of the Shareholders' status as shareholders or CPF or SRS investors, authenticated Shareholders or CPF or SRS investors will receive email instructions on how to access the webcast and audio feed of the AGM proceedings by 2.30 p.m. on 27 November 2021. Shareholders who have received the email instructions must not forward the email instructions to other persons who are not shareholders or who are not entitled to attend the AGM.

- Shareholders (including CPF or SRS investors) who do not receive an email by 2.30 p.m. on 27 November 2021, but who have registered by 2.30 p.m. on 26 November 2021 deadline, should contact the Company's Share Registrar at main@zicoholdings.com.
- (b) Submission of questions in advance

Shareholders (including CPF or SRS investors) may also submit questions related to the resolutions to be tabled for approval at the AGM:

- All questions must be submitted by 2.30 p.m. on 24 November 2021
 - via the pre-registration website at the URL <u>https://septusasia.com/ttj-agm2021-registration;</u> or
 - by email to <u>ttjde@ttj.com.sg</u>.
- Shareholders (including CPF or SRS investors) will need to identify themselves when posing questions by email with the following details:
 - the Shareholder's full name as it appears on his/her/its CDP/CPF/SRS share records;
 - the Shareholder's NRIC/Passport/UEN number;
 - the Shareholder's contact number and email address; and
 - the manner in which the Shareholder holds his/her/its Shares in the Company (e.g. via CDP, CPF or SRS).

Please note that the Company will not be able to answer questions from persons who provide insufficient details to enable the Company to verify his/her/its shareholder status.

- The Company will address substantial and relevant questions relating to the resolutions to be tabled for approval at the AGM as received from Shareholders before the AGM by uploading the responses on SGXNet and the Company's website at the URL www.ttj.com.sg on 26 November 2021.
- Please note that Shareholders will not be able to ask questions at the AGM "live" during the webcast and the audio feed, and therefore it is important for Shareholders to submit their questions in advance of the AGM.

(c) Proxy voting

Shareholders will not be able to vote online on the resolutions to be tabled for approval at the AGM. Instead, if Shareholders (whether individual or corporate) wish to exercise their votes, they must submit a proxy form to appoint the Chairman of the AGM to vote on their behalf:

- Shareholders (whether individual or corporate) appointing the Chairman
 of the AGM as proxy must give specific instructions as to his manner of
 voting, or abstentions from voting, in the proxy form, failing which the
 appointment will be treated as invalid.
- The proxy form can be submitted to the Company in hard copy form or by email:
 - if in hard copy and sent by post, the proxy form must be deposited with the Company's Share Registrar, B.A.C.S. Private Limited at 8 Robinson Road #03-00, ASO Building, Singapore 048544; or
 - if submitted by email, the proxy form must be submitted to the Company's Share Registrar, B.A.C.S. Private Limited at <u>main@zicoholdings.com</u>,

in either case, not less than 72 hours before the time for holding the AGM, and in default the instrument of proxy shall not be treated as valid.

A member who wishes to submit an instrument of proxy must first download, complete and sign the proxy form, before submitting it by post to the address provided above, or before scanning and sending it by email to the email address provided above. In view of the current COVID-19 situation, members are strongly encouraged to submit completed proxy forms electronically via email.

- CPF or SRS investors who wish to appoint the Chairman of the AGM as proxy should approach their respective CPF Agent Banks or SRS Operators to submit their votes by 2.30 p.m. on 19 November 2021 in order to allow sufficient time for their relevant intermediaries to in turn submit a proxy form to appoint the Chairman of the AGM to vote on their behalf not less than 72 hours before the time for holding the AGM.
 - Persons who hold shares through relevant intermediaries (as defined in Section 181 of the Companies Act, Chapter 50 of Singapore) ("Relevant Intermediary Participants"), excluding CPF and SRS investors, and who wish to participate in the AGM by (a) observing and/or listening to the AGM proceedings via the "live" webcast or the "live" audio feed; (b) submitting questions in advance of the AGM; and/or (c) appointing the Chairman of the AGM as proxy to attend, speak and vote on their behalf at the AGM, should contact the relevant intermediary through which they hold such shares as soon as possible in order to facilitate the necessary arrangements for them to participate in the AGM.

 The Company will, within one month after the date of the AGM, publish the minutes of the AGM on SGXNet and the Company's website, at the URL <u>www.ttj.com.sg</u>.

6. RECORD AND PAYMENT DATES FOR THE 2021 DIVIDEND

Subject to the approval of the Shareholders to be obtained for the proposed final taxexempt one-tier dividend of 0.8 Singapore cent per ordinary share (tax exempt onetier) for the reporting year ended 31 July 2021 (the "**2021 Dividend**"), the Share Transfer Books and Register of Members of the Company will be closed 5.00 p.m. on 8 December 2021 for the purpose of determining Shareholders' entitlements to the 2021 Dividend.

Duly completed and registrable transfers received by the Company's Share Registrar, B.A.C.S. Private Limited, at 8 Robinson Road #03-00, ASO Building, Singapore 048544 up to 5.00 p.m. on Tuesday, 7 December 2021, will be used to determine Shareholders' entitlements to the 2021 Dividend. Shareholders whose securities accounts with The Central Depository (Pte) Limited ("**CDP**") are credited with Shares at 5.00 p.m. on Tuesday, 7 December 2021 will be entitled to the 2021 Dividend.
