On 21 November 2016, FCAM was issued 189,631 Units as payment of the acquisition fee by FCT to FCAM in connection with the acquisition of all the strata lots comprised in the ground-floor retail podium of Yishun 10 Cinema Complex. As a result of such issuance, the total number of Units increased from 920,198,330 Units to 920,387,961 Units, and the percentage of FCL Trust Holdings Pte. Ltd.'s unitholding decreased from 38.00% to 37.99%.
