ANNOUNCEMENT

ANNUAL GENERAL MEETING TO BE HELD ON 30 SEPTEMBER 2020

- 1. Background. Stamford Tyres Corporation Limited ("Stamford Tyres" or the "Company") refers to:
 - (a) the COVID-19 (Temporary Measures) Act 2020 which enables the Minister for Law by order to prescribe alternative arrangements for listed companies in Singapore to, *inter alia*, conduct general meetings, either wholly or partly, by electronic communication, video conferencing, teleconferencing or other electronic means;
 - (b) the COVID-19 (Temporary Measures) (Alternative Arrangements for Meetings for Companies, Variable Capital Companies, Business Trusts, Unit Trusts and Debenture Holders) Order 2020 (the "Order") which sets out the alternative arrangements in respect of, inter alia, general meetings of companies;
 - (c) the joint statement by the Accounting and Corporate Regulatory Authority ("ACRA"), Monetary Authority of Singapore and Singapore Exchange Regulation ("SGX RegCo") of 13 April 2020 (and subsequently updated on 27 April 2020 and 22 June 2020) which provides additional guidance on the conduct of general meetings during the period from 27 March 2020 to 30 September 2020; and
 - (d) the Company's announcement dated **8 September 2020** on the extension of time granted by ACRA and SGX RegCo for the Company to hold its Annual General Meeting ("**AGM**").
- 2. **Date, time and conduct of AGM**. The Company is pleased to announce that pursuant to the Order, the AGM will be convened and held by way of electronic means on **Wednesday, 30 September 2020** at **3.00 p.m.** (Singapore time).
- 3. **Notice of AGM and Proxy Form**. The Notice of AGM and Proxy Form will be sent to shareholders solely by electronic means via publication on the Company's corporate website and will also be made available on the SGX website¹. Printed copies of these documents will not be sent to shareholders.
- 4. **No personal attendance at the AGM**. Due to the current COVID-19 situation in Singapore, shareholders will not be able to attend the AGM in person.
- 5. **Alternative arrangements for participation in the AGM**. Shareholders may participate in the AGM by:

- (a) observing and/or listening to the AGM proceedings via live audio-visual webcast or live audio-only stream;
- (b) submitting questions in advance of the AGM; and/or
- (c) appointing the Chairman of the Meeting as proxy to attend, speak and vote on their behalf at the AGM.

Details of the steps for pre-registration, pre-submission of questions and voting at the AGM by shareholders, including CPF and SRS investors, are set out in the Appendix to this announcement. In particular, CPF and SRS investors who wish to appoint the Chairman of the Meeting as proxy should approach their respective CPF Agent Banks or SRS Operators by **5.00 p.m. on 18 September 2020** to submit their votes.

- 6. **Persons who hold shares through relevant intermediaries**. Persons who hold Stamford Tyres shares through relevant intermediaries (as defined in section 181 of the Companies Act, Chapter 50), other than CPF and SRS investors, and who wish to participate in the AGM by:
 - (a) observing and/or listening to the AGM proceedings via live audio-visual webcast or live audio-only stream;
 - (b) submitting questions in advance of the AGM; and/or
 - (c) appointing the Chairman of the Meeting as proxy to attend, speak and vote on their behalf at the AGM,

should contact the relevant intermediary through which they hold such shares as soon as possible in order for the necessary arrangements to be made for their participation in the AGM.

- 7. **Annual Report 2020**. The Company's Annual Report 2020 has been published on the Company's corporate website and may be accessed at http://www.stamfordtyres.listedcompany.com/agm.html by clicking on the hyperlink for "Annual Report 2020"; and will also be made available on the SGX website at https://www.sgx.com/securities/company-announcements.
- 8. **Record date and payment date for first and final dividend.** The Transfer Books and Register of Members of the Company will be closed on 15 October 2020 for the purpose of determining shareholders' entitlements to the proposed first and final tax exempt (one-tier) dividend of 0.5 cent per ordinary share for the financial year ended 30 April 2020 (the "**Proposed Dividend**").

Duly completed transfers received by the Company's Share Registrar, Boardroom Corporate & Advisory Services, at 50 Raffles Place, Singapore Land Tower #32-01, Singapore 048623 up to 5.00 p.m. on 15 October 2020 (the "Record Date") will be registered before shareholders' entitlements to the Proposed Dividend are determined. Shareholders (being Depositors) whose securities accounts with The Central Depository (Pte) Limited are credited with shares as at 5.00 p.m. on the Record Date will rank for the Proposed Dividend. The Proposed Dividend, if approved at the AGM, will be paid on 29 October 2020.

STEPS FOR PRE-REGISTRATION, SUBMISSION OF QUESTIONS AND VOTING AT THE AGM

Shareholders will be able to observe and/or listen to the AGM proceedings through a live audio-visual webcast or live audio-only stream via their mobile phones, tablets or computers, submit questions in advance of the AGM and vote by appointing the Chairman of the Meeting as proxy to attend, speak and vote on their behalf at the AGM.

To do so, they will need to complete the following steps:

		Minutes of AGM . The Company will publish the minutes of the AGM on its corporate website and on SGXNet within one month from the date of AGM, and the minutes will include the responses to substantial and relevant questions from shareholders which are addressed during the AGM.

Shareholders (whether individual or corporate) who pre-register to observe and/or listen to the AGM proceedings and wish to vote on the resolutions to be tabled at the AGM must appoint the Chairman of the Meeting as their proxy to attend, speak and vote on their behalf at the AGM, in accordance with the instructions on the proxy form.
		Specific voting instructions to be given . Where shareholders (whether individual or corporate) appoint the Chairman of the Meeting as their proxy, they must give specific instructions as to voting, or abstentions from voting, in respect of a resolution in the proxy form, failing which the appointment of the Chairman of the Meeting as proxy for that resolution will be treated as invalid.
