**PAYMENT OF MANAGEMENT FEES
BY WAY OF ISSUE OF NEW UNITS IN ESR-LOGOS REIT**

ESR-LOGOS Funds Management (S) Limited, the manager of ESR-LOGOS REIT (the “**Manager**”), is pleased to announce that 11,055,204 new units in ESR-LOGOS REIT (“**Units**”) have been issued to the Manager (8,616,129 new Units) and ESR-LOGOS Property Management (S) Pte Ltd, the property manager of ESR-LOGOS REIT (the “**Property Manager**”) (2,439,075 new Units) today.

The new Units were allotted at an issue price of S\$0.3137 per Unit as partial payment for the Manager’s base fees and the Property Manager’s property management fees for the period from 1 October 2023 to 31 December 2023 (“**4Q2023**”).

The issue price was determined based on the volume weighted average price per Unit for all trades on Singapore Exchange Securities Trading Limited in the ordinary course of trading for the last ten (10) business days of 4Q2023.

Following the above issuance of new Units, the total number of Units in issue is 7,697,298,608 of which the Manager’s holding is 150,207,113 Units and the Property Manager’s holding is 35,342,074 Units, representing 1.95% and 0.46% of the total number of Units in issue, respectively.
