Award by PT Pertamina EP as Partner for Joint Operation for Trembul Area

The Board of Directors (the "Board") of GSS Energy Limited (the "Company"), together with its subsidiaries (the "Group") is pleased to announce that PT Pertamina EP ("Pertamina") has awarded PT Sarana GSS Trembul ("PT SGT"), a subsidiary company of the Group, as a partner for joint operation for production for the Trembul Operation Area.

PT SGT is a joint venture between the Group and PT Sarana Pembangunan Jawa Tengah ("PT SPJT"), with the Group holding a 49% shareholding through the Company's whollyowned subsidiary, GSS Energy Trembul Limited. PT SGT was incorporated on 28 September 2016 in the Republic of Indonesia. PT SPJT is a commercial vehicle whollyowned by the Government of Central Java and it also holds stakes in various large-scale infrastructure projects in Indonesia.

The Trembul Operation Area is situated within Blora Regency in Central Java Province, Indonesia. It lies within the Kening Trough on the onshore East Java Basin, between Purwodadi High and East Cepu High, with reservoir potentials in Ledok, Wonocolo, Ngrayong, Tawun and Kujung.

PT SGT had accepted the award on 29 September 2016 and made the opportunity cost payment of US\$0.5 million to Pertamina on the same day.

Upon the acceptance of the award, PT SGT has started discussing the Joint Operations ("JO") Agreement with Pertamina.

The Company will give further updates upon the conclusion and signing of the JO Agreement and when there are significant new developments.
