**ISSUANCE AND ALLOTMENT OF 411,888 ORDINARY SHARES IN THE CAPITAL OF THE COMPANY PURSUANT TO THE TRICKLESTAR PERFORMANCE SHARE PLAN**

*Unless otherwise defined, capitalised terms used herein shall bear the same meanings ascribed to them in the Company's announcement dated 10 December 2019, 26 February 2021, 28 February 2022 and 25 March 2022 ("**Previous Announcements**").*

Further to the Previous Announcements, the Board wishes to announce that the Company had, on 13 June 2022 allotted and issued 411,888 new ordinary shares (the "**Award Shares**") in the capital of the Company, which is a partial issuance pursuant to the Awards vested under the TrickleStar Performance Share Plan (the "**PSP**").

Following the allotment and issuance of the Award Shares, the issued and paid-up share capital of the Company has increased from 82,674,915 shares to 83,086,803 shares.

The Award Shares rank *pari passu* in all respects with the existing shares of the Company. The Award Shares are expected to be listed and quoted on the Catalist Board of the Singapore Exchange Securities Trading Limited on or before 15 June 2022.
