## UPDATE ON OPERATIONS FOLLOWING CIRCUIT BREAKER MEASURES BY SINGAPORE GOVERNMENT

On 3 April 2020, the Multi-Ministry Taskforce of the Singapore Government announced a set of elevated safe distancing measures to pre-empt the trend of increasing local transmission of COVID-19 ("Circuit Breaker Measures"). Save for those providing essential services and in selected economic sectors which are critical for local and global supply chains, physical workplace premises are required to cease operations from 7 April 2020 until 4 May 2020.

The board of directors ("Board") of Alliance Healthcare Group Limited (the "Company" and together with its subsidiaries, the "Group") wishes to update the Company's shareholders of the status of the Group's operations following implementation of the Circuit Breaker Measures.

The Group's principal business comprises 4 main segments, namely: (i) Managed Healthcare Solutions; (ii) GP Clinics Services; (iii) Specialist Care Services; and (iv) Pharmaceutical Services. As most of the services provided by the Group's 4 main business segments and Jaga-Me Pte. Ltd. (a 55%-owned subsidiary acquired by the Group in January 2020) fall within the scope of essential services which are permitted to continue to operate and the Group has obtained exemption from suspension for such services, the Group's business activities remain substantially operational.

During this period, the Group will temporarily cease those services deemed as non-essential such as elective medical procedures.
