("AF Global"), a company in which each of Aspial Corporation Limited ("Aspial") and FGL holds 50 per cent. of the issued shares in, entered into a conditional sale and purchase agreement (the "Agreement) with Aspial, Mr Koh Wee Seng ("Mr Koh Wee Seng") and Mdm Tan Su Lan (Mdm Tan Su Lan, together with Aspial and Mr Koh Wee Seng, the "Sellers"), pursuant to which AF Global agreed to purchase from the Sellers all the issued ordinary shares in the capital of the Company ("Shares") held by the Sellers comprising, in aggregate, 304,946,000 Shares, representing approximately 28.89 per cent. of the total issued Shares, for an aggregate cash consideration of \$\$74,159,973.32 (the "Transaction").

(ii) Completion of the Transaction is subject to and conditional upon the satisfaction of the condition precedent set out in the Agreement.

(iii) FGL holds not less than 20 per cent. of the issued shares of AF Global and is deemed to have an interest in the Shares in which AF Global has an interest.
