Boustead Projects Limited ("Boustead Projects" or the "Group") – a leading specialist in real estate solutions – is pleased to announce that it has been awarded a design-and-build contract by HSBC Institutional Trust Services (S) Limited as trustee of repeat client, AIMS AMP Capital Industrial REIT ("AA REIT") for the redevelopment of an industrial property located in Marsiling, Singapore ("the Facility").

Construction of the Facility – a five-storey industrial facility redevelopment – is expected to commence shortly and be completed by the second half of calendar year 2017.

The latest contract awarded to Boustead Projects by AA REIT follows after the award of another redevelopment design-and-build contract by AA REIT in April – the construction of which is progressing well on schedule.
