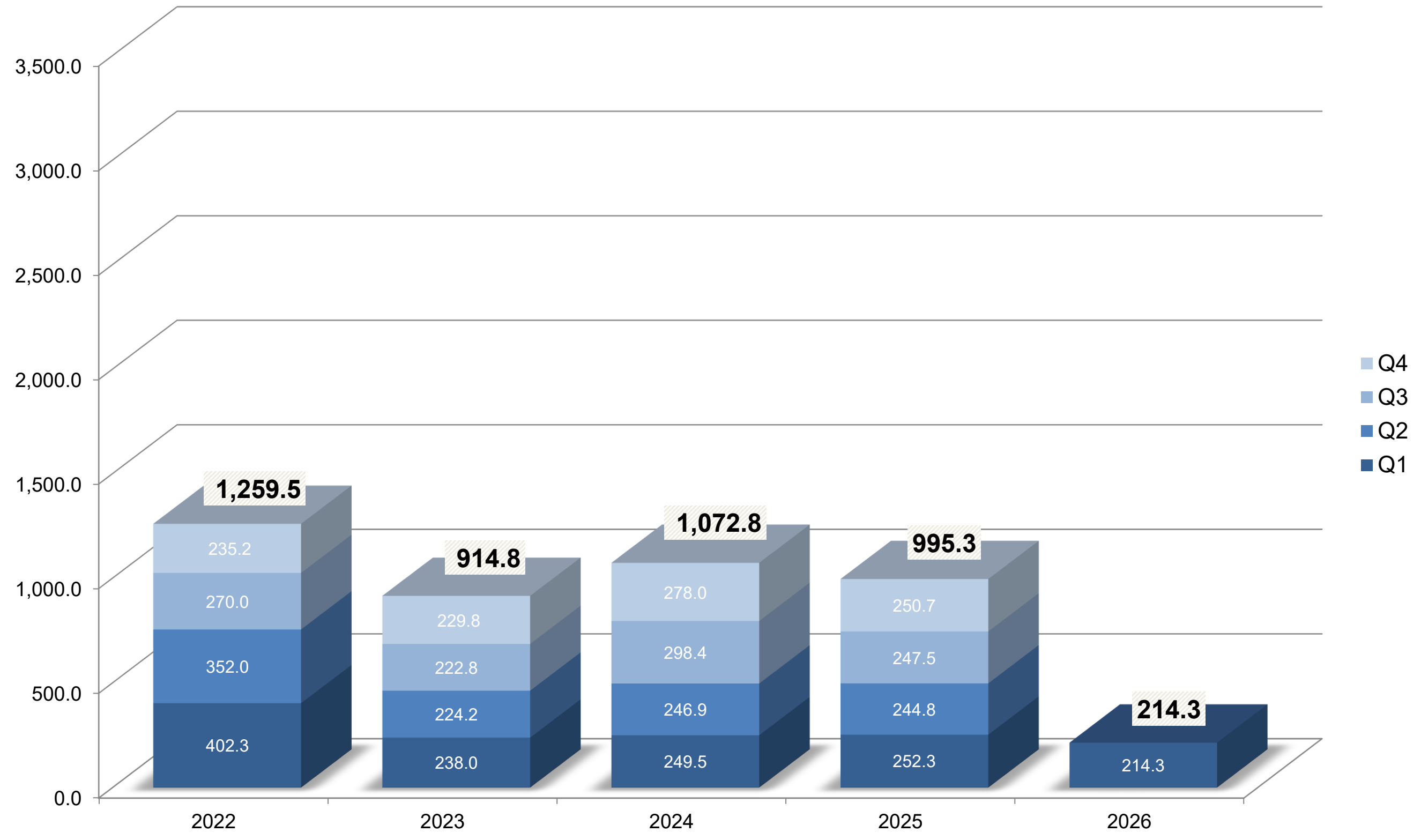

Revenue (RM'million)

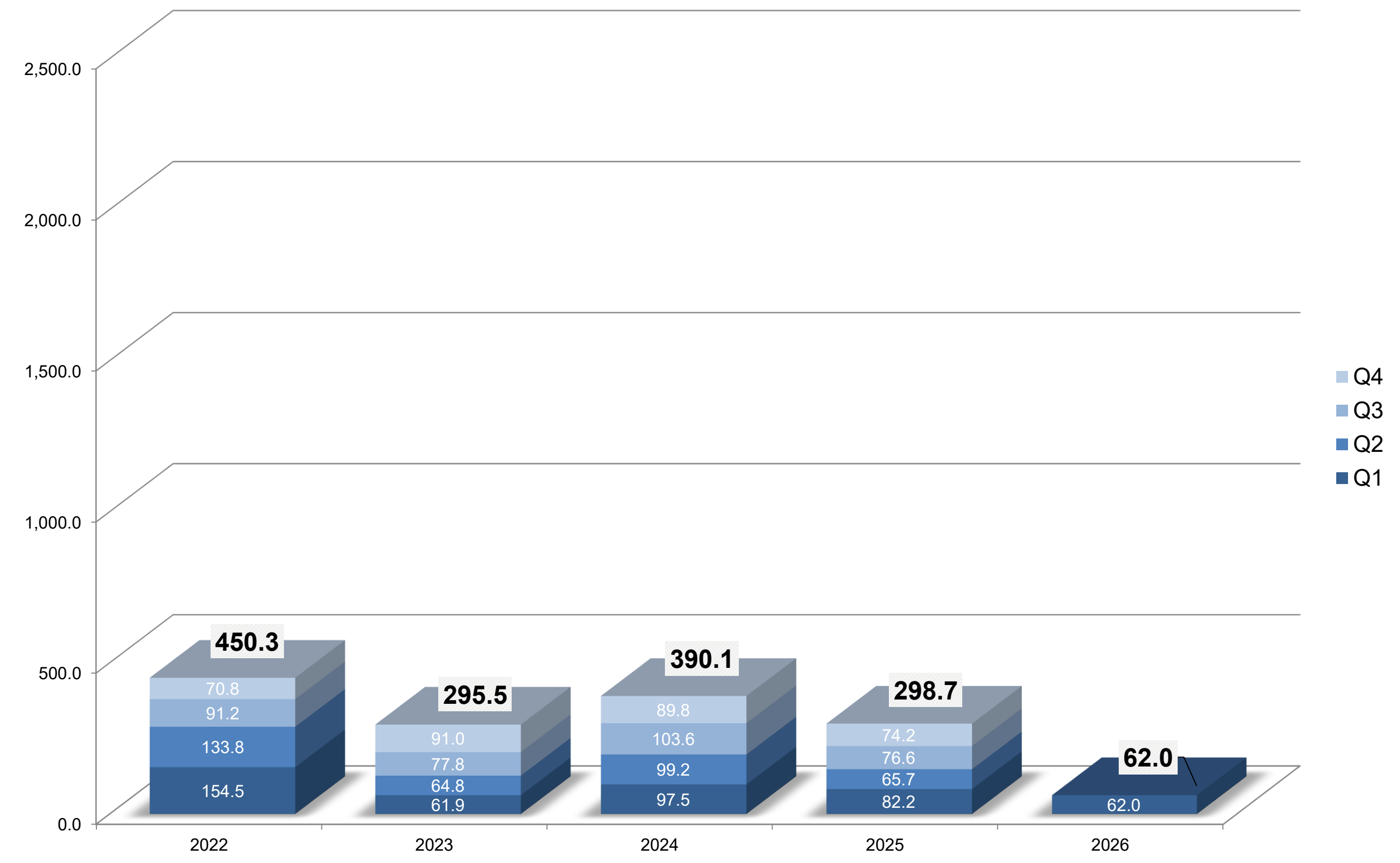

Gross Profit (RM'million)

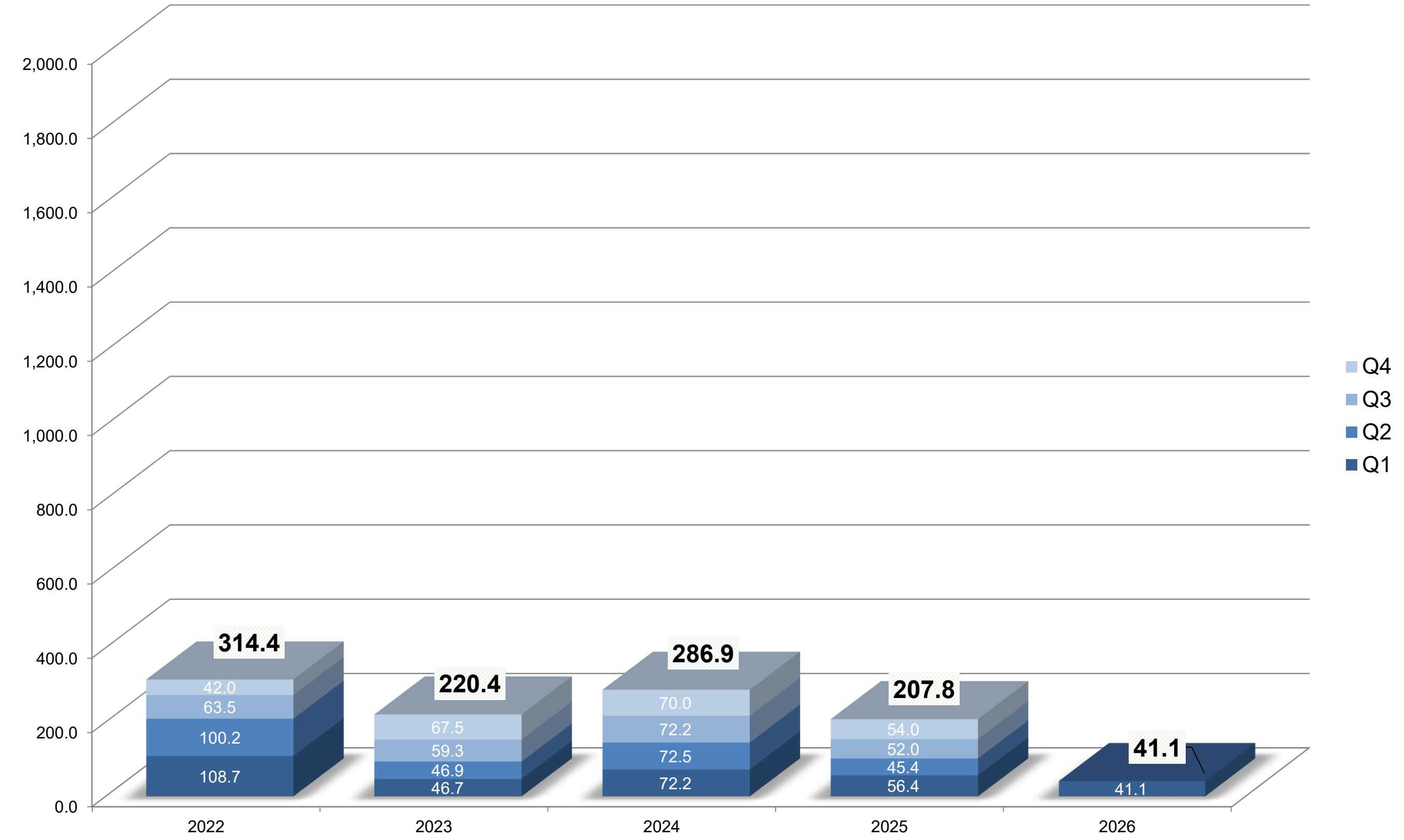
