A reverse convertible note ("RCN") was issued by JP Morgan to Mr Wee on 3 July 2020, pursuant to which Singtel shares (being one of the counters in the underlying basket of securities of the RCN) might be delivered to Mr Wee at a pre-determined strike price on the maturity date of the RCN, depending on performance of the underlying basket of securities as at the final valuation date. The 133,278 Singtel shares were delivered to Mr Wee at the maturity of the RCN based on the performance of the underlying basket of securities, in accordance with the terms of the RCN.

In respect of the 249,738 shares in which Mr Wee has a direct interest, 228,278 shares are held in the name of UBS AG and 20,400 shares are held in the name of Bank of Singapore.
