ANNOUNCEMENT

COMPLETION OF DIVESTMENT OF STAKES IN COMPANIES HOLDING 10 RETAIL MALLS IN CHINA

Further to its announcement dated 5 January 2018 regarding the proposed divestment of stakes in companies holding 20 retail malls in China, CapitaLand Limited ("CapitaLand") wishes to announce the completion (the "Completion") of the divestment by its subsidiaries and associates of their respective equity interests in the companies set out in Appendix 1 of this announcement (collectively, the "Sale Companies"). The Sale Companies hold 10 of the 20 retail malls in China.

Following the Completion, the Sale Companies have ceased to be subsidiaries or associated companies of CapitaLand, as the case may be.

The completion of the divestment by CapitaLand's subsidiaries and associates of their respective equity interests in the companies holding the remaining 10 retail malls in China, is expected to take place by the end of 2018.
