PAYMENT OF MANAGER'S FEES BY WAY OF ISSUE OF NEW UNITS IN ESR-REIT

ESR Funds Management (S) Limited, the manager of ESR-REIT (the "Manager"), wishes to announce that 3,997,722 new units in ESR-REIT ("Units") have been issued to the Manager today. The new Units were allotted at an issue price of S\$0.5326 per Unit as partial payment for the Manager's base fees for the period from 1 April 2019 to 30 June 2019 ("2Q2019").

The issue price was determined based on the volume weighted average price for a Unit for all trades done on the Singapore Exchange Securities Trading Limited ("SGX-ST") in the ordinary course of trading on the SGX-ST for the last ten (10) business days of 2Q2019.

Following the above issue of new Units, the total number of Units in issue is 3,383,351,165 of which the Manager's holding is 35,324,685 Units representing 1.04% of the total number of Units in issue.
