NTEGRATOR WINS THREE CONTRACTS WORTH S\$9.0 MILLION IN SINGAPORE, MYANMAR AND VIETNAM

- Two equipment supply contracts awarded by Myanmar's Directorate of Procurement and Viettel, Vietnam's largest mobile network operator
- Awarded a pipeline installation and maintenance services contract in Singapore
- Cumulative value of Ntegrator's order wins in 2015 at approximately S\$68.0 million

Singapore, December 16, 2015 – Ntegrator International Ltd ("Ntegrator" or "the Group"), a leading regional communications network specialist and systems integrator, announced today that it has secured three contracts worth approximately S\$9.0 million from repeat customers in Singapore, Myanmar and Vietnam.

The first contract was awarded by the Viettel Group, Vietnam's largest mobile network operator with a growing international presence. The contract involves the supply of the "Narada" brand of batteries, accessories and spare parts to Viettel Group. The second contract, awarded by Myanmar's Directorate of Procurement, involves the supply of spare parts for fiber optic cables (FOC) and base transceiver stations (BTS).

The abovementioned contracts are slated for progressive delivery over the next twelve months and are expected to bring positive contributions to the Group's financial performance for the financial year ending December 31, 2016 ("FY2016"), subject to timely completion of the project and effective cost management.

The Group was also awarded a 12-month contract commencing in December 2015 for pipeline installation and maintenance services in Singapore. This contract was awarded by a regional service provider, and is expected to contribute positively to the Group's financial performance in FY2016, subject to timely completion of the project and effective cost management.

Mr. Jimmy Chang, Managing Director of Ntegrator, commented, "We are pleased to close 2015 on a high note, with the latest contracts lifting our cumulative order wins in 2015 to nearly S\$68.0 million. This order intake reaffirms the solid fundamentals of our business and demonstrates how Ntegrator is well-placed to benefit from burgeoning opportunities in the regional network and telecommunications sector."
