CIVMEC SECURES \$160M OF CONTRACTS FOR THE AMRUN PROJECT

PERTH/SINGAPORE – 12 December 2016 – Australia-based **Civmec Construction & Engineering Pty Ltd** has been awarded two significant contracts totalling AUD\$160 million as part of the development of a processing facility for Rio Tinto's Amrun project near Weipa in North Queensland.

The Amrun Project involves the construction of a bauxite mine and associated processing and port facilities on the Cape York Peninsula in north Queensland.

The larger of the contracts, awarded includes:

- the construction of the Process Facility including a bauxite beneficiation plant and associated water, electrical and lighting systems; and
- a combined total of 11,800 tonnes of Australian steel and precast concrete, with the fabrication, precast manufacture and modular assembly taking place at both Civmec's east coast facility at Newcastle, NSW and west coast facility at Henderson, WA.

Works on the Project Facilities contract will commence immediately and at peak along with the onsite works will give employment to over 500 personnel across the Henderson and Newcastle facilities. The project is due for completion at the end of 2018.

The second contract, awarded by Sandvik, includes the part supply, fabrication, surface treatment, mechanical and electrical install and the modularisation of a stacker, reclaimer and shiploader for bauxite material handling. This contract involves the fabrication of 2,200 tonnes of steel, and the works will be completed at the Civmec's Henderson Facility.

Mr. Patrick Tallon, Chief Executive Officer said: "We are appreciative to Rio Tinto and Sandvik for the award of these contracts. Civmec will proudly carry out the work for the Amrun Project in Australia, creating local jobs and providing a boost for the Australian economy."

"These awards demonstrate that Civmec, as a leading heavy engineering constructor, has bridged the gap between the Australian and overseas fabrication options. With our high quality, schedule assurance and price competitiveness, Rio Tinto has acknowledged that a local delivery is the best option for this important Australian project.
