#### PAYMENT OF BASE COMPONENT OF MANAGEMENT FEE BY WAY OF ISSUE OF UNITS IN CAPITALAND MALL TRUST

CapitaLand Mall Trust Management Limited (the "**Company**"), as manager of CapitaLand Mall Trust ("**CMT**"), wishes to announce that 414,848 units in CMT ("**Units**") have been issued today at an issue price of S\$1.9645 per Unit to Premier Healthcare Services International Pte Ltd ("**Premier**"), an entity nominated by the Company to receive the 414,848 Units in its place.<sup>1</sup>

The abovementioned Units have been issued as payment of the base component of the management fee for the period from 1 April 2017 to 30 June 2017 (both dates inclusive), in relation to CMT's 40.0% interest in RCS Trust, which owns Raffles City Singapore.

With the abovementioned issue of Units, the total number of Units in issue is 3,545,794,411. As the Units have been issued to Premier, the total number of Units held by the Company remains unchanged at 44,918,236 Units.
