**ALLOTMENT, ISSUE AND LISTING OF NEW UNITS UNDER THE
DISTRIBUTION REINVESTMENT PLAN**

Sabana Real Estate Investment Management Pte. Ltd., in its capacity as manager of Sabana Shari'ah Compliant Industrial Real Estate Investment Trust ("**Sabana REIT**"), and as manager of Sabana REIT, the "**Manager**", wishes to announce that 492,892 new units in Sabana REIT ("**Units**") have been allotted and issued at an issue price of S\$0.8713 per new Unit to eligible unitholders of Sabana REIT ("**Unitholders**") who have elected to participate in the distribution reinvestment plan ("**DRP**") in respect of the distribution of 1.78 cents per Unit for the period from 1 January 2015 to 31 March 2015 (the "**Distribution**").

Distribution payments to eligible Unitholders who did not elect to participate in the DRP would have been paid in cash on 29 May 2015.

The new Units, which have been allotted and issued on 29 May 2015, will commence trading on the Main Board of Singapore Exchange Securities Trading Limited (the "**SGX-ST**") at 9.00 a.m. on 29 May 2015.

The new Units will rank *pari passu* in all respects with the existing Units.

Following the issue of the new Units, the number of issued Units has increased from 728,702,354 to 729,195,246.
