

PAYMENT OF MANAGEMENT FEE BY WAY OF ISSUE OF UNITS IN KEPPEL REIT

The Board of Directors of Keppel REIT Management Limited (the "**Company**"), as manager of Keppel REIT, wishes to announce that 26,548,914 Units ("**Management Fee Units**") in Keppel REIT have been issued today at a price of S\$0.8507 per Unit as payment of its management fee as follows:

The issue price per Management Fee Unit is the volume weighted average price of a Unit for all trades done on the Singapore Exchange Securities Trading Limited (the "SGX-ST") in the ordinary course of trading for the period of ten business days immediately preceding 31 December 2024, being the last business day for the period.

The payment of the management fee and the manner of such payment are provided for in the trust deed dated 28 November 2005, as may be amended from time to time, constituting Keppel REIT (the "**Trust Deed**"). It is provided in the Trust Deed that from Keppel REIT's financial year ended 31 December 2008 and onwards, the Company is entitled to receive its management fee in a combination of Units and cash in such proportions as it may elect. For the period from 1 October 2024 to 31 December 2024, the Company has elected to receive 100% of the base fee component of its management fee in the form of Units. For the period from 1 January 2024 to 31 December 2024, the Company has elected to receive 100% of the performance fee component of its management fee in the form of Units.

Following the issuance of the Management Fee Units, the Company's unitholding in Keppel REIT has increased to 186,927,615 Units, representing approximately 4.83% of the total number of issued Units in Keppel REIT. The total number of issued Units in Keppel REIT as at the date of this announcement is 3,870,594,655.
